Measures to support accessibility

EBSCO Information Services takes the following measures to ensure accessibility of EBSCO Mobile:

- Include accessibility throughout our internal policies
- Appoint an accessibility officer
- Provide continual accessibility training for our staff
- Assign clear accessibility targets and responsibilities
- Employ formal accessibility quality assurance methods
- Include people with disabilities in our design personas

Conformance status

The [Web Content Accessibility Guidelines \(WCAG\)](#) defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA. EBSCO Mobile is partially conformant with WCAG 2.1 level AA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard.

Limitations and alternatives

Despite our best efforts to ensure accessibility of EBSCO Mobile, there may be some limitations. Below is a description of known limitations, and potential solutions. Please contact us if you observe an issue not listed below.

Known limitations for EBSCO Mobile:

1. **eBook Content:** Semantic structure may not be exposed to screen readers because EBSCO's eBooks use Adobe DRM technology, which does not easily expose document semantics for use by consuming applications. We are exploring the possibility of surfacing the semantics in the mobile app. There is no timetable for this as it is in the architectural research phase. The text of eBooks is available for use by screen readers, which is not the case in other mobile Adobe DRM applications.
